# SMART GOVERNMENT MONITORING POPULATION ADMINISTRATION IN GATTARENG TOA VILLAGE, MARIORIWAWO SUBDISTRICT, SOPPENG DISTRICT

Abstract--This study aims to design and apply smart government monitoring of population administration applied by using Hypertext Preprocesor (PHP), MySql and C# with online server in Gattareng Toa Village, Marioriwawo Subdistrict, Soppeng District. This data is obtained through (1) Field Research, (2) Research Library, and (3) Interview. Data were analyzed by pieces analysis. The results of the study indicated that the Smart Government Monitoring Population Administration can help the system of population administration work in monitoring Population Administration in Gattareng Toa Village, Marioriwawo Subdistrict, Soppeng District.

## I. INTRODUCTION

Technology development increasingly fast now demanding efficiency and effectiveness of work in improve service to the community. With a system then data processing will be more easy and efficient. Make things happen the government has issued Presidential Instruction no. 3 of 2003 in the framework of implementing e-government or Smart Government in the government environment. This innovation provides new values to the public (public), these values are created from the government through services, regulations, laws and others [1].

Population administration services are part of public services that must be organized by the state to meet the needs of the community in the administrative field. **Population** administration is an important need to be fulfilled because it involves determining the citizenship status of a resident as evidenced by the population documents they have [7]. Current condition, some services carried out by the government still use manual methods such as the process of making ID cards, birth certificates, family cards, and others. A citizen must face-toface to the officer concerned at the government office. This is very ineffective and efficient because it costs more than the actual and perceived costs to be very troublesome because they have to go to the government office [2]. Likewise, some survey results from international survey institutions show that public services in Indonesia are still the worst in Asia in terms of public services. Likewise, various studies have been carried out by observers of public services, with all of them concluding that public services through direct contact with various administrative practices, namely a practice that deviates from administrative ethics [6].

Marioriwawo Subdistrict consists of 11 villages and 2 villages, while the object of the research is Gattareng toa Village, Gattareng Toa has a population of 2,540 people with a total of 702 households as of April 2017 each year not less than 50 reports of making good decrees birth, death, or transfer or mutation in these two villages. Archiving is the main thing if there is a report on the making of the decree, but there are still files that do not match what they should. The community must come to the village office by bringing the required documents such as family cards and KTP (identity card) of each citizen who entered the report as well as information from the doctor and midwife on the reporting of birth and information from village officials, health or police in case of death, this becomes complicated if people have to carry so many files.

The background of the problems described above, the researchers took the initiative to create a system that became a tool to facilitate data processing and assist in making reports that can be carried out effectively and efficiently in the process of making KTP in Gattareng Toa Village, Marioriwawo District, Soppeng Regency. Based on the explanation of the background of the problem, the formulation of the problem in this study is as follows How to make a smart government system in the process of monitoring population administration in Gattareng Toa Village and how is the implementation of the smart government system in the process of monitoring population administration in Gattareng Toa Village?

Limitation of problems contained in the population management information system in making birth certificates, deaths and transfers or mutations. The analysis focused on the process of making the Certificate and the design of the smart government system that was made leading to the process of reporting / making birth certificates, deaths and transfers or mutations. In terms of users, those who will use this application are the community as the reporter and the village apparatus and the subdistrict administrative apparatus. The object of the research is only in the scope of the Marioriwawo sub-district, namely the Gattareng Toa Village. The purpose of this research is as follows: Creating a smart government system based on mobile android in making birth, death and moving SK or mutase decrees. Implement smart government systems in monitoring population administration in Gattareng Toa. The benefits of this research are People will be easier to report the occurrence of births, deaths and moves or mutations only through mobile android to facilitate village officials and subdistrict officials in handling the administration of incoming reports.

The concept of smart city was originally implemented in the United States and the European Union. At first smart city aimed to create regional independence and improve public services. According to Pratama, Smart city or literally means smart city is a concept of developing, implementing, and implementing technology that is applied to a region (Especially Urban) as a complex interaction between various systems in it[3].

According to [3], Smart City has several parts in it including: Smart Economy, Smart People, Smart Government, Smart Mobility, Smart Environment, and Smart Living. As for the reference in this study is the Smart Government section which is a part or dimension that specializes in governance. Smart Government includes all the requirements, criteria and objectives for the process of empowerment and participation of the community and government together. The existence of cooperation between the government and the community is expected to realize governance and the way of a clean, honest, fair and democratic government and better quality and quantity of public services.




Fig. 1. Use case diagram

In this use case we can see several actors, namely the Village Apparatus and the community as reporters, both actors must log in first to access certain functions as shown in Figure 1.

## 2. Sequence Diagram




Fig. 2. Sequence diagram

There are 3 (three) sequence diagrams of the Smart Government Administration Monitoring Unit in the village of Gattareng toa namely. The administrative phase of village population data starts from logging in, then the village apparatus will be redirected to the main page to input the KK data and AK data on the form that has been provided, then from that data will enter a report which will be checked and stored in the form of a certificate. as shown in Figure 2




Fig. 3. Sequence diagram report

The next sequence diagram is reporting on birth and death, the stage starts from the community in this case the reporter logs in using NIK and full name. as shown in Figure 3.




Fig. 4. Moving report

Moving report is the last sequence diagram, the stage starts

from login using NIK and full name, after that the reporter makes a report of moving domicile by filling out the report form and mentioning the name of another family member if there are several family members who moved. After the report goes to the village apparatus, the village apparatus checks the report and finally prints the decree (certificate) and gives the decree to the reporter. as shown in Figure 4.




Fig. 5. Building and Installation

The results of the archive are then distributed into the APK form and saved into the project folder, while the distribute view can be seen in the picture as shown in Figure 7.




Fig. 6. Build project




Fig. 7. APK form




Fig. 12. Login page

The program manual consists of two parts namely website and android, the website program manual consists of the login page as below. As shown in Figure 12.
