Not long after the President handed over the Heritage Flag, the President was arrested and exiled by the Dutch along with the Vice President and other presidential staff to Muntok, Bangka Island, Bangka-Belitung Province

The basic similarity in meaning between "nationalism" and "national spirit" is that both terms refer to a strong sense of loyalty to the country and its people. Early definitions of nationalism centered on the idea that it is a state of mind expressed in a person's unwavering loyalty to his or her country. #### CONCLUSION

The contribution of heritage flags can increase nationalism in the younger generation by instilling strong national principles starting from coaching through materials, providing systematic national insight, to physical training. This can be realized through routine activities at school, such as arriving early to raise the red and white flag, respecting the red and white flag and being solemn when listening to the national anthem Indonesia Raya. Another example is when students see the Red and White flag falling, students who see this will pick it up and tie it back to the flagpole. Just like when the Red and White flag looks dirty, they take the flag home to be washed and returned the next day.

In this case it can be concluded that the students actually have a high spirit and sense of nationalism, but they lack literacy about nationalism itself. Here the role of the heritage flag's contribution as an extracurricular becomes very important considering the contribution of the heritage flag in providing material and guidance related to nationalism in terms of theory and implementation when exercise.
